REGULATIONS ON THE INTERNATIONAL COMPETITION

"People of Artek"

(hereinafter referred to as the Regulations)to participate in educational programs8 shifts of 2024 at the Federal State BudgetaryEducational Institution "MDC "Artek"

1. General provisions

- 1.1. This provision determines the procedure for organizing and conducting a competitive selection of children to participate in educational programs of the 8th shift in 2024 of the federal state budgetary educational institution "International Children's Center "Artek" (hereinafter IDC "Artek") "People of Artek" (hereinafter the Competition).
- 1.2. The organizers of the Competition are the Autonomous non-profit organization "Center for Support of Public Projects "Let's Do It Together" (hereinafter referred to as the Organizer). The coorganizer of the Competition is the federal state budgetary educational institution "International Children's Center "Artek" (hereinafter referred to as the Co-organizer).
- 1.3. The partners of the competition are the Ministry of Foreign Affairs of the Russian Federation, the Ministry of Education of the Russian Federation, the "World of Opportunities" project of the All-Russian political party "UNITED RUSSIA", Rossotrudnichestvo, the State Corporation "Rosatom", the Federal State Educational Institution of Higher Education "National Research University "Higher School of Economics" hereinafter Partner(- s).
- 1.4. Regulations on the Competition are posted on the official website of the Promotion https://artek-contest.com and MDC "Artek"www.artek.org.
 - 1.5. The competition is held from March 4, 2024 to July 15, 2024
 - 1.6. Participation in the competition is free.
- 1.7. When conducting the Competition, the Organizer is guided by the current legislation of the Russian Federation.
- 1.8. The Contest participant must read these Regulations and comply with the rules specified therein.
 - 1.9. The working languages of the Competition are: Russian, English.

2. Purpose of the Competition

2.1. The purpose of the Competition is to highlight the activities of the «Artek» as a world-famous children's center, as well as to attract children's audiences to study the hundred-year history of the «Artek».

3. Dates of the Competition

3.1. The competition consists of several stages: registration, first and second stages.

March 4, 2024 - announcement of the Competition;

from March 4 to April 30, 2024 - registration on the portal https://artek-contest.com in the prescribed form;

from May 1 to May 15, 2024 – first stage: submission by Participants of the Competition in their personal account (portal https://artek-contest.com) portfolio of the results of your activities.

from May 16 to May 25, 2024 – second stage: portfolio assessment and determination of the winners of the Competition by the competition commission (determining the number of Participants from countries depending on the number of countries that took part in the Promotion).

until June 1, 2024 – publication of the results of the Competition.

from July 15 to August 5, 2024 - the winners of the competitive selection will take part in the educational program of the 8th shift of the Artek MDC (enrollment of the winners of the competitive selection is carried out taking into account the norms and requirements in the field of sanitary and epidemiological safety, including regional ones and the students' country of residence).

4. Organizing Committee of the Competition

- 4.1. General management of the organization and conduct of the Competition is carried out by the Organizing Committee (hereinafter referred to as the Organizing Committee), which is formed from among the employees of the Competition Organizer, the UNITED RUSSIA party, the Artek International Children's Center, as well as other partners of the Competition as agreed.
- 4.2. Decisions made by the Organizing Committee within its competence are binding on the participants of the Competition, as well as all persons involved in organizational, preparatory and practical work during the implementation of all stages of the Competition.
 - 4.3. The Organizing Committee has the right:
- form the composition of the competition commission, including specialists experts in the relevant field, to evaluate the materials sent by the Participants during the Competition;
- make proposals to extend or change the timing of the Competition; perform other tasks and functions related to the conduct and preparation of the Competition.
- decisions of the Organizing Committee are reflected in the corresponding minutes and signed by the chairman and secretary of the Organizing Committee.

5. The terms of participation

- 5.1. Participants of the Competition are children (foreign citizens and young comptaiots) aged 12 to 17 years (hereinafter referred to as the Participant).
- 5.2. In accordance with the Rules for the admission of children to the «Artek» (http://artek.org/informaciya-dlya-roditelyay/kak-poluchitsya-putevku-v-artek/) During the summer period, children from 8 to 17 years old inclusive are accepted, who must not have turned 18 before the end of the shift to which they are assigned.
- 5.3. A child can be sent to the Artek Medical Center no more than once a year, regardless of the type of quota: thematic, regional, special or commercial.
- 5.4. Foreign citizens (hereinafter referred to as the Participant) take part in the competition on a voluntary basis.
- 5.5. A completed application of the established form (Annex 1) by default confirms the Participant's familiarization with these Regulations and voluntary consent to the collection, storage, use, distribution (transfer) and publication of the Participant's personal data, as well as the results of his work, including on the Internet, and confirmed by the personal signature of the Participant.
- 5.6. Before submitting an application for participation in the Competition, the Participant must familiarize himself with the procedure for admitting children and the rules for their stay at the Artek

International Children's Center, indicated on the official website<u>https://artek.org/</u> in the "Information for Parents" section for subsequent compliance.

- 5.7. Restrictions on participation in the Competition:
- Only individual participation in the Competition is allowed; team works are not accepted.
- The enrollment of the winners of the Competition in the «Artek» is regulated by the enrollment of children in the educational program of the «Artek» in accordance with the requirements for the preparation of medical documents: information about medical contraindications for referral to the «Artek». Issues related to medical contraindications for children with disabilities must first be agreed with the head of the medical and sanitary department of the «Artek» and receive official confirmation of the possibility of admitting them to the «Artek».
- 5.8. Contest materials that do not meet the requirements of these Regulations and are executed in violation of the requirements of these Regulations are rejected by the Organizer and Co-Organizer without explaining the reasons for the refusal.

6. Procedure for the Competition

- 6.1. To participate in the Competition you must register on the portal https://artek-contest.comBy registering on the portal to participate in the Competition, Participants thereby confirm their agreement with these Regulations, and also express their desire to provide the targeted results of their activities for expert and public viewing and discussion, publication in the media and specialized publications.
- 6.2. *First stage of the competition*—submission by the Competition Participants in their personal account (portal https://artek-contest.com) portfolio of the results of your activities.
- 6.3. In each country, a competition commission is formed that evaluates the Participant's portfolio presented by the Contest Participant on the portal https://artek-contest.com
- 6.4. **Second stage of the competition**—represents an assessment of the portfolio of the Competition Participants by the competition committee.
 - 6.5. The portfolio of the Competition Participants is assessed as follows:
- 6.5.1. The competition commission formed in the Participant's country evaluates the portfolio of the Competition Participants in accordance with the evaluation criteria specified in Table 1, Appendix
- 6.5.2. Contestants' materials are available to the competition commission through their personal account on the portal https://artek-contest.com.
- 6.5.3. The final score of the Participant in the first stage of the Competition is determined as the sum of points given by all members of the competition committee.
- 6.5.4. The works of the Contestants that have received the maximum number of points are submitted for evaluation to the Competition Commission, formed in the Russian Federation from among representatives of the Competition Partners (clause 1.4.).
- 6.5.5. Members of the competition commission formed in the Russian Federation from among representatives of the Competition Partners (clause 1.4.) evaluate the competitor's portfolio, assigning points in accordance with the evaluation criteria Table 2 of Annex 2.
- 6.5.6. The final score of the winner is determined as the sum of points given by all members of the competition committee.

- 6.6. Depending on the number of submitted applications, the number of places is distributed among countries; the winners of the Competition are the Participants who score the maximum number of points in their country.
- 6.7. All documents and applications provided by the Participant are subject to verification by the Competition Organizer for compliance with the validity of the specified data.
- 6.8. The participant does not have the right to exert any influence on the representatives of the competition commission, on the results of the Competition and the procedure for its conduct.
- 6.9. In case of violation of the rules of the Competition by the Participant, the Organizer and the Co-Organizer may refuse him further participation in the Competition.
- 6.10. The decision of the competition commission is formalized in the form of a written protocol, which is signed by all members of the commission.

7. Competition tasks

- 7.1. Represented by the Participant registered in his personal account on the website https://artek-contest.com, materials for the Competition must be provided in one of the following languages: Russian, English.
- 7.2. The Competition Participant's portfolio must be uploaded to the personal account on the websitehttps://artek-contest.comand include:
 - 7.3. Required elements (tasks) of the Competition:
 - 7.3.1. Conducting presentation lessons about Artek in your educational institution, including:
 - Promotional presentation about Artek (mandatory element).
- At the request of the participant, the lesson about Artek may include a presentation based on materials from research or project work (additional element)
 - 7.4. Additional elements (tasks) of the Competition:\
- 7.4.1. Conducting research work about an Artek resident/Artek hero from the country of residence.

The research work should include:

- A brief summary about the Artek member/hero, which indicates: the reason for choosing a particular Artek member/hero, a story about how "Artek" influenced the personality/hero, the author's attitude towards the Artek member, an assessment of the relevance and social significance of the topic.
- A detailed biography of the Artek member/hero, containing basic facts (date and place of birth, education, labor and social activities, participation in political, professional, volunteer movements, etc.), information about the Artek member's connection with Artek and other facts that, in the opinion of The participant should be brought. The biography should indicate sources of information with links.
- 7.4.2. Carrying out project work based on the results of the "Manifesto of Friendship" adopted at the Artek during the 2023 international shift (Annex 3), with the possibility of further implementation within the framework of the Artek shifts.

Project work should include:

- presentation of the project outlining goals, objectives, description of activities, expected results from them, including indicators of audience coverage.
 - a list of the first steps to implement the project.
- 7.5. Prepare a report on all the work done, which will include: information about lessons conducted, research and project work. As confirmation, the Participant must provide photo or video materials of lessons and presentations about Artek.
 - 7.6. Requirements for the materials provided:
 - 7.7. A report on the work done is provided in the form of a presentation using various design

techniques. including photographic materials with a quality of 2560 * 1600 pixels in JPG format (diagrams, graphs, stands, layouts, crafts, drawings made in different techniques, books made personally, if desired, participants attach video materials (video objects, their own videos, cartoons). Volume - no more than 15 slides.

- 7.8. All files and video materials are presented as a free link to the file (available without a password via the link, uploaded to Yandex.Disk, Google.Drive, Mail.ru Cloud).
- 7.9. Materials to which access will be closed will not be considered by the competition commissions.
 - 7.10. Works that participated in the previous year are not allowed to participate in the Competition.

8. Summing up the Competition

- 8.1. To evaluate competitive works based on the results of the first stage, a competition commission is formed in each country.
- 8.2. The commission carries out an examination of the submitted competitive materials, assigning points in accordance with the evaluation criteria (Annex 2).
- 8.3. To evaluate competitive works based on the results of the second stage, a Commission is formed to determine the winners.
- 8.4. The results of the competitive selection are published on the official website of the Organizer (https://artek-contest.com) and Co-organizer of the Competition (https://artek.org/).
- 8.5. Participants receive information about the results of participation in the Competition personally after completing the stage to the personal email addresses specified during registration.
- 8.6. All Participants of the Competition are awarded Participant certificates, and the winners of the competition are awarded diplomas of winners.
- 8.7. Participants of the Competition who score the maximum number of points based on the results of the Competition are awarded a personalized diploma and a free trip to the Artek International Children's Center to participate in the 8th shift educational program.
 - 8.8. The Competition winner's diploma is personal and cannot be transferred to third parties.
- 8.9. The results of the competitive selection accepted by the competition commission are final and are not subject to adjustment.
- 8.10. All materials submitted to the Competition will not be returned or reviewed. Appeals based on the results of the competition will not be accepted.

9. Results of the Competition

- 9.1. The results of the Competition are published on the website of the Organizer and Co-Organizer of the Competition no later than 5 (five) working days from the date of the official summing up of the Competition results.
- 9.2. In accordance with the final protocol, the winners of the competition are given a diploma of the winner of the Competition (hereinafter referred to as the Diploma), confirming the successful completion of all stages of the competitive procedures (clause 5. of these Regulations) and an incentive with a ticket to the 8th shift in 2023 at the Artek International Children's Center.
- 9.3. The Organizer sends the winner's diploma indicating the number of the shift and the dates of its holding at the "Artek" to the email address specified by the winning participant when submitting the Application no later than 10 (ten) working days after summing up the results of the Competition.

- 9.4. From the moment of receiving the Diploma, the Participant, within 10 days, independently registers in the automated information system "Artek" on the website www.artek.children. In the personal account during registration, the Participant fills out his profile in full, first of all adding the winner's diploma and documents confirming the best personal achievements (on the topic/direction of the Competition) over the past 3 (three) years. (Members of teams and artistic groups add certificates and team/group diplomas).
 - 9.5. Applications without an attached winner's diploma will be rejected.
- 9.6. Along with sending the Certificate, the parents of the Competition winner are informed about the procedure for preparing the necessary documents for a trip to the Artek International Children's Center.
- 9.7. Parents (legal representatives) of the winner of the Competition must, no later than 10 days from the date of publication of the results of the Competition, send an email to <u>info@artek-contest.ru</u> a letter confirming the child's readiness to take part in the educational session of the "Artek" within the specified time frame.
- 9.8. In case of refusal to receive a voucher by one of the Participants who have passed the competitive selection, the right to receive a free voucher is transferred to the Participant next in the ranked list.
- 9.9. In the event that the winner of the Competition refuses to receive the trip, the monetary equivalent of the cost is not paid or compensated.
- 9.10. In the event of any personal circumstances that prevent the winner of the Competition from taking part in the program, a shift change is not possible in this case.
- 9.11. Participants who are not registered with the "Artek" are not allowed to participate in the Program.

10. Additional provisions

- 10.1. The participant guarantees that the work was performed personally by him; copyright materials of minors are posted with the consent of their parents (legal representatives).
- 10.2. In case of presentation of demands, demands, suits of third parties, including copyright holders and related rights to the submitted work, the Participant undertakes to resolve them on his own behalf at his own expense.
- 10.3. The Organizing Committee is not responsible for compliance with copyright and related rights to works presented in the competition program of the Competition.
- 10.4. The Organizing Committee of the Competition reserves the right to use competition works for non-commercial purposes and without paying monetary compensation to the author: carrying out socially significant events and advertising campaigns created on the basis of competition works; distribution of these products in educational organizations; reproduction of materials for the needs of the Competition, full or partial use for educational or other purposes.

11. Financial conditions for participation in the Competition

- 11.1. Collection of payment from Participants (in any form) for participation in the Competition is not permitted.
- 11.2. Travel of the Competition Participants to the Artek International Children's Center, as well as back, is paid for by their parents or guardians or legal representatives. If it is necessary to stay at the base-hotel (branch) of the Artek, before enrollment in the shift program or after the end of 21 days of stay at the Artek, the stay at the base-hotel is paid for at the expense of the parents/guardians/legal representatives in accordance with with accommodation rates. Transportation costs and expenses associated with issuing a health insurance policy, as well as notarized translation of all necessary documents into Russian (for foreign children), are paid by parents/guardians/legal representatives. It is allowed to pay travel expenses of competition participants at the expense of

Partners.

1.1.	The reason for choosing a specific topic to describe the fate of the Artek man (feat)	from 1 to 5 points – the reason for the choice is disclosed sufficiently/insufficiently
1.2.	Connection of the selected person with "MDC "Artek"	from 0 to 5 points – no connection/there is a connection

Contestant's thoughts/analysis/observations about the person chosen for the description, literacy	from 1 to 10 points – the contestant's attitude towards the Artek citizen being described is not revealed enough/sufficiently, the contestant answered the question: "Why was a specific person chosen for the description", admitted /there are no grammatical or stylistic errors.

The commission has the right to add from 3 to 5 to the overall assessment of the summary if the short summary is submitted in the original form and reveals a larger number of topics necessary to evaluate the application (for example, in the summary, in addition to the required points, the task of describing the feat, the uniqueness of the described feat, events and etc.)

2.	Criteria for assessing the submission of a biography of the Artek resident described:	
2.1.	Biography submitted in original format	from 2 to 5 points, where 5 points is the highest score of originality
2.2.	Availability of photos	0 – no photos, 0-3 points – photos are present
2.3.	Availability of information sources	1 – sources of information are indicated; Reduction by 10 points if sources of information are not indicated

The commission has the right to add 1-5 points to the overall biography score, if the hero's biography indicates and discloses significant events that, in the Participant's opinion, reveal the character of the Artek member, the influence of "Artek" on his formation and fate.
